# REPORT TO CITY COUNCIL

#### SUBJECT:

Award of Contract for the Street Improvements in Zediker Avenue between Fresno Street and Merced Street for Federal Project No. STPL-5252(027).

#### RECOMMENDATION:

Staff recommends the City Council adopt Resolution 2020-\_\_\_\_, awarding the contract for the Street Improvements in Zediker Avenue between Fresno Street and Merced Street for Federal Project No. STPL-5252(027) to Don Berry Construction, Inc., in the amount of \$209,655.85, approve a contingency of 10% of the contract amount equal to \$25,000.00. and authorize the City Administrator or Mayor to sign the Agreement with Don Berry Construction, Inc.

#### BACKGROUND:

The Zediker Avenue Reconstruction project received Federal Transportation Lifeline funds for the Road Reconstruction of Zediker Avenue between Fresno Street and Merced Street. The project will construct new asphalt and base rock, new concrete curb, gutter and sidewalk and ADA compliant concrete curb ramps along the west side of Zediker Avenue and striping on the east side of Zediker Avenue. The City received \$188,793.00 in Federal Lifeline funds and the City will use Local Funds for the remaining portion of construction for the project. Bids were received from seven (12) contractors on Wednesday, March 4, 2020. The lowest responsive and responsible bidder was Don Berry Construction, Inc. with a Bid in the amount of \$209,655.85. The Engineer's Estimate was \$245,922.95.

Bids were received from eleven (12) contractors and the results were as follow:

Staff has reviewed the bid submitted by Don Berry Construction, Inc. along with information regarding their previous work experience. Based on the information submitted, staff has determined Don Berry Construction, Inc. to be a responsible contractor.

#### FISCAL IMPACT:

Based on the actual bids, the total estimated project cost for the project is \$287,100.00, which includes Design Engineering, Construction Management and Construction Testing. The original funding allocation was \$209,393.00 from Federal Lifeline funds and \$44,607.00 from Local Funds. This project will use additional Lifeline funds to cover the additional construction costs.

SUBJECT: APPROVAL OF RESOLUTION No. 2020-22 OF THE CITY OF PARLIER AUTHORIZING SUBMITTAL OF APPLICATION(S) FOR ALL CALRECYCLE GRANTS FOR WHICH CITY OF PARLIER IS ELIGIBLE

#### **BACKGROUND:**

The California Department of Resources Recycling and Recovery (CalRecycle) offers funding opportunities authorized by legislation to assist cities in the safe and effective management of the waste stream. Currently, the city has an open Tire Derived Product grant for recycled rubber mulch. The city has purchased the rubber mulch but was not able to lay all of the rubber mulch in time for the grant deadline. The state has allowed us to extend the deadline until March 2021. In order for the city to extend the deadline, a new resolution must be approved.

Cal Recycle uses "5-year" resolutions. This resolution gives us the ability to apply for this, and other CalRecycle grants, within the next 5 years.

# RESOLUTION OF THE CITY OF PARLIER AUTHORIZING SUBMITTAL OF APPLICATION(S) FOR ALL CALRECYCLE GRANTS FOR WHICH CITY OF PARLIER IS ELIGIBLE

WHEREAS, Public Resources Code sections 48000 et seq. authorize the Department of Resources Recycling and Recovery (CalRecycle) to administer various grant programs (grants) in furtherance of the State of California's (state) efforts to reduce, recycle and reuse solid waste generated in the state thereby preserving landfill capacity and protecting public health and safety and the environment; and

WHEREAS, in furtherance of this authority CalRecycle is required to establish procedures governing the application, awarding, and management of the grants; and

WHEREAS, CalRecycle grant application procedures require, among other things, an applicant's governing body to declare by resolution certain authorizations related to the administration of CalRecycle grants.

NOW, THEREFORE, BE IT RESOLVED that the City Council authorizes the submittal of application(s) to CalRecycle for all grants for which City of Parlier is eligible; and

BE IT FURTHER RESOLVED that the Board President (Mayor), or City Administrator, is hereby authorized and empowered to execute in the name of the City of Parlier all grant documents, including but not limited to, applications, agreements, amendments and requests for payment, necessary to secure grant funds and implement the approved grant project; and

BE IT FURTHER RESOLVED that these authorizations are effective for five (5) years from the date of adoption of this resolution.
