#### **BACKGROUND:**

Resolution 2022-51 is the transfer of the grant deed, real property described in the attached Certificate of Acceptance. Sarbat Bhala Inc. purchased the property from the city to build a training center on or before Jan. 1, 2018, but the construction was never commenced so the property thereby the city demanded the property to be returned. This resolution is to accept the Deed for Real Property.

Resolutions 2022-52 is with respect to grant deeds delivered to the City pursuant to the terms of a purchase and sale agreement previously authorized by the City Council, the City's intent to accept the deed is demonstrated by the purchase and sale or other acquisition agreement previously approved by the City Council.

With respect to property acquired by the City pursuant to a negotiated purchase of real property by the City pursuant to an agreement previously approved by the City Council, the City wishes to designate its Deputy City Clerk as having blanket authority to execute Certificates of Acceptance which are required by law in order to record a deed in favor of the City.
