REPORT TO COUNCIL

SUBJECT:

Approve the City Manager as Agent on behalf of the City of Parlier and hereby authorize to execute for and on behalf of the City of Parlier an application to file with the California Governor's Office of Emergency Services for obtaining federal financial assistance for existing or future programs.

RECOMMENDATION:

City staff recommends the City Council adopt Resolution No. 2023-10 authorizing the Approval of the City Manager as Agent on behalf of the City of Parlier and hereby authorize to execute for and on behalf of the City of Parlier an application to file with the California Governor's Office of Emergency Services for obtaining federal financial assistance for existing or future programs.

BACKGROUND:

In a catastrophic disaster, and if the state's governor requests, federal resources may be mobilized through the U.S. Department of Homeland Security's Federal Emergency Management Agency (FEMA) for federal assistance to state or local governments to pay part of the costs of rebuilding a community's damaged infrastructure.

On December 27, 2022, Governor Newsom Proclaimed a State of Emergency in Fresno County due to the severe storms and urban flooding. It was ordered that: As necessary to assist local governments and for the protection of public health and the environment, state agencies shall enter into contracts to arrange for the procurement of materials, goods, and services necessary to quickly assist with the response to and recovery from the impacts of these storms. Applicable provisions of the Government Code and the Public Contract Code, including but not limited to travel, advertising, and competitive bidding requirements, are suspended to the extent necessary to address the effects of these storms.

Federal assistance has been provided through FEMA, who coordinates with Cal OES to implement the Public Assistance (PA) Grant Program.

The mission of the Federal Emergency Management Agency's (FEMA's) Public Assistance (PA) Program is to provide assistance to State, local, Territorial, or Tribal, and local (SLTT) governments, and certain types of private nonprofit (PNP) organizations so that communities can quickly respond to and recover from major disasters or emergencies declared by the President. Through the PA Program, FEMA provides supplemental Federal grant assistance for debris removal, emergency protective measures, and the restoration of disaster-damaged, publicly owned facilities and specific facilities of certain PNP organizations. The PA Program also encourages protection of these damaged facilities from future incidents by providing assistance for

hazard mitigation measures. FEMA provides this assistance based on authority in statutes, executive orders (EOs), regulations, and policies.

We must submit this request for Public Assistance (RPAs) via FEMA's Grants Portal by March 15, 2023.

FISCAL IMPACT:

Costs for damages incurred and work performed between 12/27/22 and 02/24/23 will be reimbursed at 100%. Reimbursement drops to 75% after the 60 days of the incident period. Small project threshold: \$3,800 - \$1 million and large project threshold: \$1 million and greater.

REPORT TO CITY COUNCIL

SUBJECT: City of Parlier partners with Fresno County Rural Transit Agency to conduct a Transit Microgrid Feasibility Study Event on March 14, 2023, at Heritage Park from 3:30 PM to 6:30 PM.

RECOMMENDATION: Staff invites the council and community to attend the event on March 14, 2023, at Heritage Park from 3:30 PM to 6:30 PM and give us your input.

BACKGROUND: The Fresno County Rural Transit Agency (FCRTA) provides public transit service in rural areas within Fresno County. FCRTA is embarking on an innovative project to create transit microgrids and community resiliency hubs to expand transportation access, improve air quality, and support local communities. Microgrids are small, independent power systems that use sustainable energy (like solar or wind) to power everything from electric buses to cell phones. The goal of the microgrid study is to build community resiliency/mobility hubs with solar-powered microgrids and amenities like community electric vehicle chargers, rain gardens, and backup power for emergency officials. The event will be very interactive. It's an opportunity for residents to learn more about the project and give us their input on the amenities they want at the microgrid resiliency hubs.
