

Since the expenditure of funds requires legislative authorization through an appropriation, and since an appropriation is for a specific and limited period of time (e.g., fiscal year), the failure of a city council to adopt a budget prior to the beginning of the fiscal year means that there is no legal authorization to spend money in the new fiscal year.

#### **DISCUSSION:**

Due to staff turnover and other extenuating circumstances the proposed budget cannot be timely completed and presented to City Council by June 30, 2023. If the City Council does not adopt a budget by June 30, for the ensuing fiscal year, the City Council may adopt a Continuing Resolution to ensure that the city meets payroll and contractual obligations and continues to provide services. Hence, staff recommends that the City Council adopt a Resolution approving the continuing operations of the City of Parlier and making appropriations for Fiscal Year 2023-24, all in accordance with the budget adopted for Fiscal Year 2022-2023.

The city currently is using the support of Jolly and Assoc. who provided us support to bring closing our 2023 budget year so we go into our budget preparations with a solid base.

#### FISCAL IMPACT:

If the City Council fails either to adopt a budget or to adopt a continuing resolution (to carry forward the prior fiscal year's appropriations), there can be no expenditure of city funds because there is no legal authorization (appropriation) to spend those funds.

WHEREAS, the City of Parlier is required by law to adopt a balanced budget every fiscal year on or before July 1; and

WHEREAS, pursuant to applicable law, the City may appropriate the expenditures of funds only in accordance with a budget duly adopted on or before July 1; and

WHEREAS, the City through its finance department has estimated the revenue available to the City of Parlier for fiscal year 2023-2023 to be at or above the level of revenues anticipated for and actually received during fiscal year 2022-2023; and

WHEREAS, the City of Parlier estimates for fiscal year 2023-2024, unless action is taken by this Council which causes an increase in expenditures, that expenditures for fiscal year 2023-2024 will be at or below the levels anticipated and actually experienced for fiscal 2022-2023; and

WHEREAS, the City's best estimate of the level of expenditures and revenues that will actually be experienced in fiscal year 2023-2024 is the same as those anticipated by the budget adopted for fiscal year 2022-2023; and

WHEREAS, because of the need to devote staff time to more urgent matters, the 2023-2024 budget has not been completed and it is anticipated that it will not be completed prior to July 1, 2023.

#### NOW, THEREFORE, BE IT RESOLVED as follows:

- 1. The foregoing recitals are true and correct.
- 2. The budget approved by the City Council for fiscal year 2022-2023 is hereby adopted as the budget for fiscal year 2023-2024, temporarily, until such time as the budget for fiscal year 2023-2024 has been completed at which time the

Council will amend this Resolution and/or adopt the budget for fiscal year 2023-2024.

3. Expenditures are authorized to made are hereby appropriated as provided for by the fiscal year 2022-2023 budget which is by this Resolution, temporarily adopted as the budget for the City of Parlier for fiscal year 2023-2024. Expenditures not contemplated or authorized by the 2022-2023 fiscal year budget must be specifically authorized by this City Council which, in that authorization, must identify the revenues necessary to fund those expenditures over and above the level of expenditures for which funds are available as set forth in the 2022-2023 fiscal year budget.

#### SUBJECT:

Accept Grant Funding from the California Highway Patrol (CHP) Cannabis Tax Fund Grant Program to Reduce Impaired Driving in the City of Parlier

#### RECOMMENDATION:

Adopt Resolution 2023- XX authorizing the City Manager to accept the "Cannabis Tax Fund Grant Program (CTFGP)" and enter into the grant agreement and any amendments to fund impaired driving detection/investigation training for officers, community educational programs and supplemental impaired driving enforcement. The tentative grant allocation is \$79,841.80 for the period of July 1, 2023 through June 30, 2024.

#### **BACKGROUND:**

Grant funding would build upon our current traffic safety efforts by allowing patrol and motor officers opportunities to address traffic safety and impaired driving – in addition to and outside of their regularly scheduled duties.

The funding is for education, prevention, and the enforcement of laws related to driving under the influence of alcohol and other drugs, including cannabis and cannabis products. The intent of the program is to educate the public regarding the dangers of impaired driving, enforce impaired driving laws on the roadway, and improve Agency's effectiveness through training and development of new strategies.

The funds will provide opportunities for all of our officers to be trained in developing skills in recognizing, interpreting and administering the Standardized Field Sobriety Tests, write reports, and testify in court for cases involving driving under the influence.

#### FISCAL IMPACT:

There is no fiscal impact for adopting the authorizing resolution to accept funding. There is no match requirement and/or leveraging of funds required.
